The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs.0.48 Lakhs being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan on or before **19.01.2026 at 4 PM.**
- f. Auction would commence at Reserve Price, as mentioned above.
