Fuel Cashback Offer Details

- Customers/Cardholders to do the fuel filling from any nearby authorized fuel station.
- The cumulative transactions amount to be Rs.100 and above.
- **The payment at fuel stations should be done by the customers through their Credit card only.**
- Customers will get a cashback of Rs.100/- and the same will be adjusted against their next credit card bill.
- The offer will be applicable on fuel MCC.
- First 50,000 customers based on transactions date and time will be provided with cashback.

Eligibility:

- Card issued between 29.11.2025 to 31.12.2025 and transaction period for fuel filling till 15.01.2026 are eligible for this offer.
- For Inactive credit card customers, first financial transaction should be by the way of fuel filling after reactivation.
- Fuel Transactions done through **Add-on cards** are also eligible for reimbursement.
- If Primary/Add-on/multiple inactive cards are activated for single customer id then all the cards are eligible to get cashback of Rs.100/- each and cumulative amount will be adjusted in the primary card bill.
- For Pre-Approved primary/add-on credit card customers, First financial transaction should be by the way of fuel filling.
- Corporate Credit Cards are not eligible for this offer.
