- f. After payment of the EMD amount, the intending bidders should submit a copy of the following documents/details on or before **27.01.2026** upto 5 p.m. to Canara Bank, ARM Branch by hand or by email.

- g. Auction would commence at Reserve Price, as mentioned above.
