The undersigned proposes to sell the vehicle more fully described in the Schedule of Sale Notice.

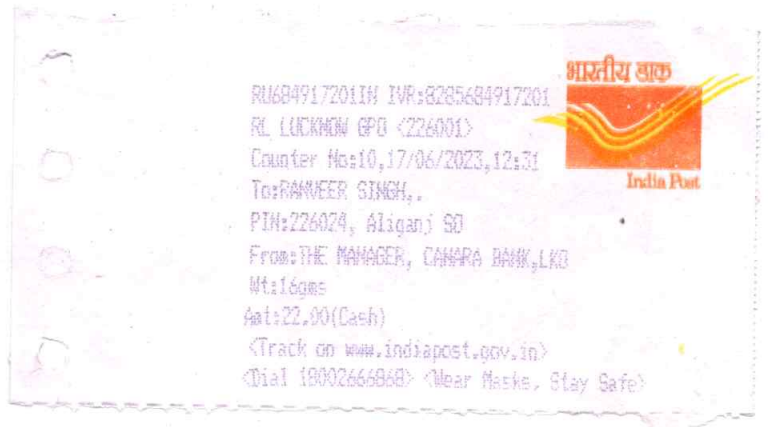
