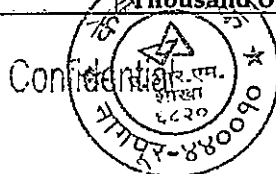

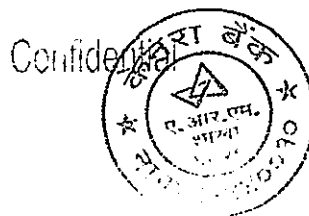
e. 


