Comprehensive Warranty (Clause 13, page 9),(Annexure C, Pt.18 & 19, page 32) Determination of L1 Price:-The L1 bidder will be determined on the basis of the lowest price (Cost of safes) quoted for the subject supply, installation, commissioning & CAMC of Dual Biometric access system for 4 years after completion of warranty period. Please Note:-TRTL Safe along with Dual Biometric access system for to be provided with at least 03 year warranty period.	Three vendors have suggested to reduce the comprehensive warranty for the TRTL including biometric lock from 3 years to one year except M/s Godrej. 3	CAMC (Comprehensive AMC)—(Clause 13, page 9),(Annexure C, Pt.18 & 19, page 32) Determination of L1 Price:-The L1 bidder will be determined on the basis of the lowest price (Cost of safes) quoted for the subject supply, installation, commissioning & CAMC of Dual Biometric access system for 4 years after completion of warranty period.	All four vendors have not agreed for the 4 year CAMC after warranty of 3 years	CANNOT BE CHANGED THE CLAUSE TO REMAIN SAME AS PER ORIGINAL TENDER TERMS & CONDITIONS
4.	TIME PERIOD:- (CLAUSE B-3/3.1 page 13) The supply & delivery of the safes has to be completed with in a period of 30 days from the date of receipt of the purchase order by the bidder. The safes should be made operational with in 30 days from the date of receipt of the purchase order by the bidder.	All vendors has suggested increase the time period from one month to 1-2 months.	TIME PERIOD MAY BE REVISED TO 45 DAYS FOR DELIVERY FROM DATE OF WORK ORDER
5.	Security Deposit (Clause 9/9.1, page 17):- The successful bidder should submit a security deposit for 5% value of the contract with-in 14 days from the date of receipt of the banks purchase order. If the security deposit is not submitted with-in the stipulated time, Bank reserves rights to cancel the order & forfeit the EMD.	M/s Guardwell & M/s Gunnebo has requested to reduce the security deposit from 5% to 2%. In writing except M/s Godrej & M/s Methodex.
