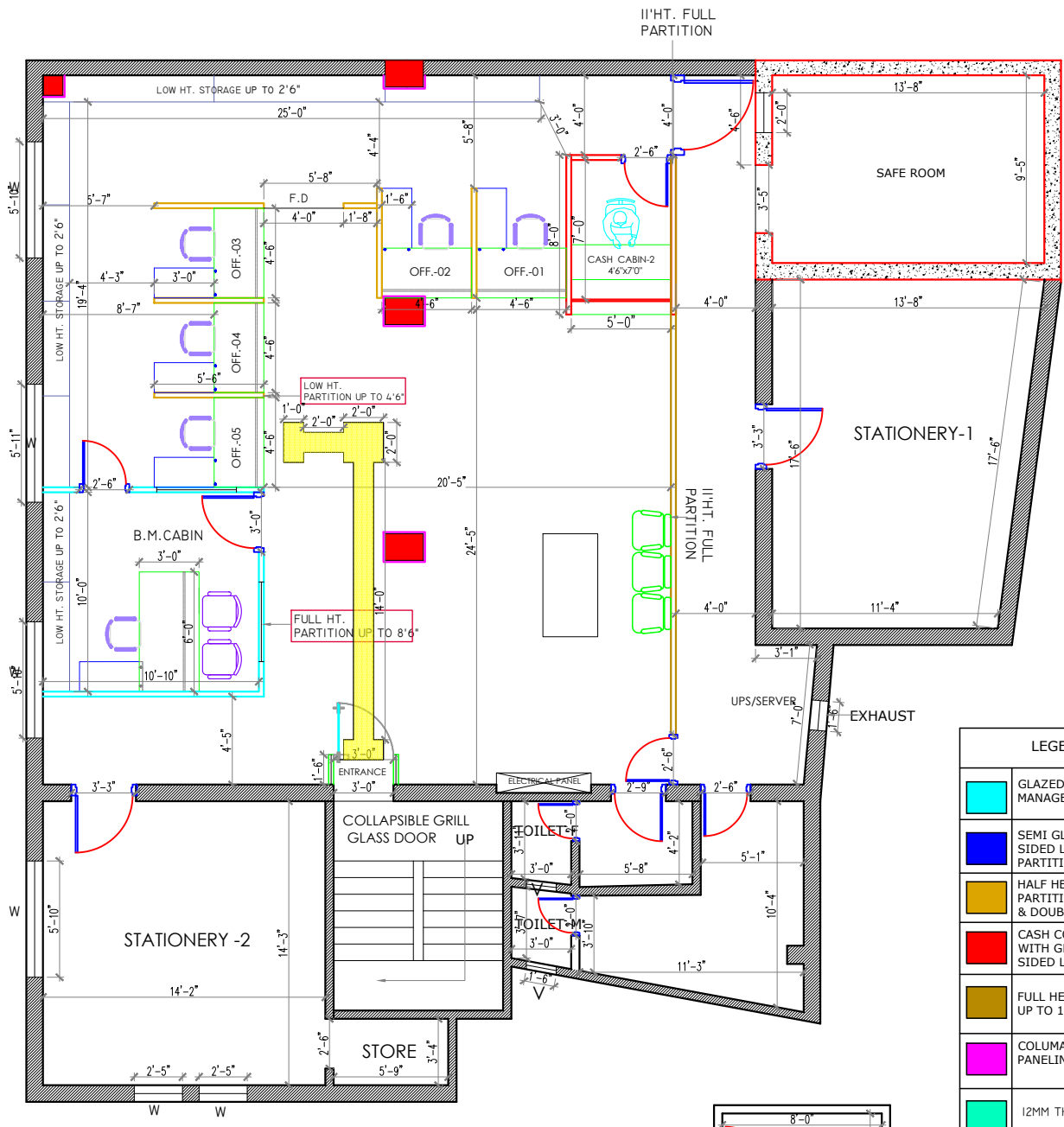
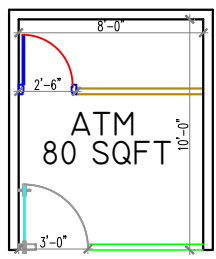


PROPOSED LAYOUT PLAN

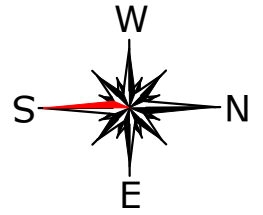
