

## ANNEXURE - I

### **GENERAL TERMS AND CONDITIONS:**

1. The successful bidder will be given Work Order on periodical basis in respect of publication of the auction notices under SARFAESI Act / RDB Act in the leading newspapers as and when required. The matter to be advertised along with the names of the newspapers would be intimated along with the requisition.
2. The rates offered by the successful bidder will remain unchanged during the period of the Work Order. However, the benefit of downward rates, if any, is to be given to the Bank.
3. The rate to be offered should be all inclusive. However, GST as applicable will be extra. No other charges / taxes would be considered.
4. The Bank reserves the right to give a special work order to any other agency for any particular public notice during the period of the Work Order.
5. The Work Order may be cancelled at any time before the expiry of its term due to non-satisfactory performance of the agency or if it is felt necessary by the authority for the interest of the Bank.
6. Time is the essence of the work order. It is to be ensured that the matters are to be published in the newspapers on the day as per the requirement of the Bank.
7. The Tender will be opened on 08.01.2026 at 11:00 AM in the presence of bidders or their authorized representatives who may choose to be present. *Please Note - If the bidder/s or their authorized representative/s fail to be present during the opening of tender than bank will proceed for opening of tender even in their absence.*
8. Bank at its own discretion may cancel any or all the bids without assigning any reason thereof. Further, Bank retains the right to cancel the bid at a later date even after the contract is awarded.
9. No Brokers / Intermediaries shall be entertained. Canara Bank reserves the right to accept or reject any or all offers in full / part without assigning any reasons whatsoever.
