4 Servicing & Maintenance

The firm/vendor shall be responsible for servicing and maintenance for the period of one year. In case the vendor fails to execute the order in time, the Bank may cancel the contract and award the same to any other vendor, without notice.

Terms for Comprehensive AMC work (TO BE DONE BY VENDOR):

- Serviceability of Pumps and Motors. Greasing and oiling as may be required to be done by the vendor only.
- All valves to be checked for its serviceability. Greasing and oiling to be done. Valves in all floor landings to be check.
- Rubber hoses to be treated with French chalk, drums to be oiled.
- Canvas hoses to be checked / Internal inspected manually for wear and tear.
- All hinges of hose boxes /duct door to be oiled for free movement.
- Practical testing by operating the pump, check hydrant pressure at ground. Close ground hydrant and check pressure on top floor.
- Check jockey / booster pumps if any for serviceability.
- Once in a while check the system through alternate power supply / diesel pump.
- In case of emergency, Vendor should visit and attend the complaint at site within 4 hours. For operating issues, Vendor should visit and fix the issue within 2 days.
- Once in quarter servicing and checking needs to be done as a part of preventive maintenance and site visit report needs to be submitted to Bank at the time of servicing. This is apart from any breakdown call during the maintenance period. Copies of service reports need to be submitted at the time of Invoice submission for payment processing.

Penalty: In case of not attending/clearing the complaint, penalty of Rs.200/- per day will be levied.

5 **Warranty**

Vendor should ensure that the components supplied (as may be required /approved by the Bank) are new and should carry the required warranty. The equipment/gadget MUST conform to relevant BIS/IS Standards.

6 **Modality**

The interested service provider may visit the site before Responding /submitting the tender. The visit details be co-ordinated with Admin Deptt, Canara Bank Circle Office Mumbai, C-14, G Block, Bandra East Mumbai – 400 051

Inspection be completed during the period 05.12.2025-24.12.2025 between 11.00 AM to 5.00 PM after taking permission.

7 **General Conditions**

a. Expenses incurred by the applicant in applying, attending, discussions/ meetings etc. shall not be reimbursed/paid by the Bank.

b. If information and details furnished by applicants are incomplete or found to be false at any time in future or any information withheld, which comes to the notice of the Bank at the later date, the contract of such vendor is liable to be cancelled immediately.

c. The contract shall be initially **Informal** for a period of **TWO YEARS**. It can be renewed further for another 1 year as per the CAMC rates mentioned in the tender after ensuring satisfactory completion of services rendered during CAMC period and submission of visit report.

8 **Payment Terms**

CAMC Charges will be paid Quarterly, after completion of quarter.
