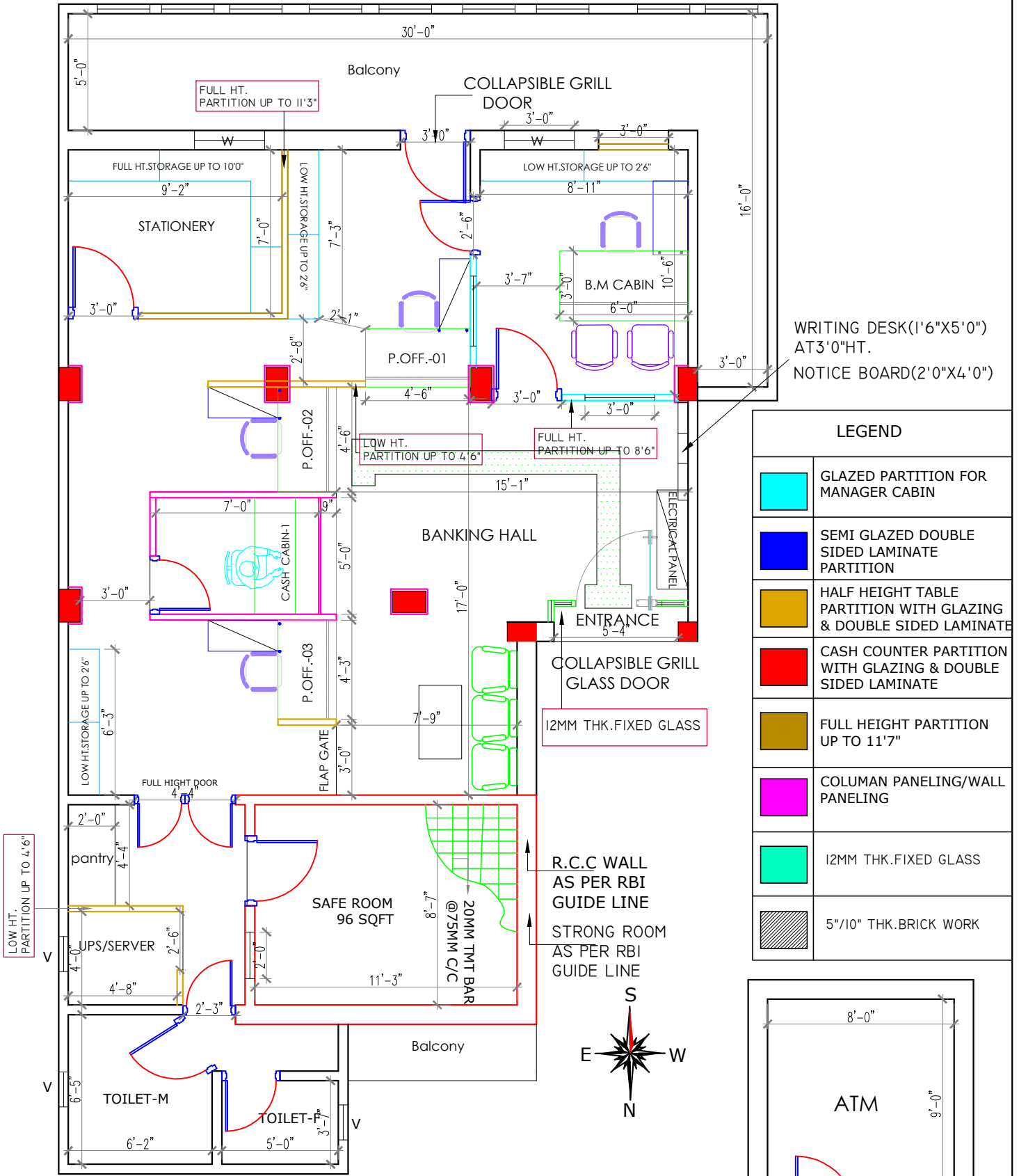
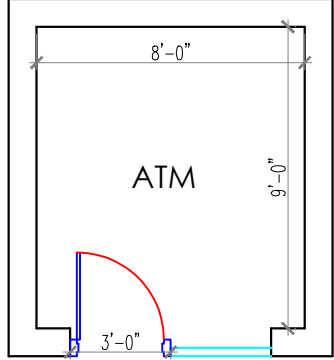


PROPOSED LAYOUT PLAN
